

## POSTDOCTORAL POSITION

Astronomical Observatory Institute at the Adam Mickiewicz University in Poznań is seeking a postdoctoral researcher to be funded by the Polish National Science Centre. The appointment is available for a period of 4 years, subject to a mid-term evaluation after 2 years. The current grant end date is 29 April 2025, so employment beyond this date is subject to the likely extension of the grant duration. Funding for computing resources and travelling is included. The starting date is expected to be in the summer or fall 2021 and is negotiable. The salary is 10 000 PLN per month (around 6 000 PLN per month after tax). The candidate will be working in the group of dr. hab. Michał Michałowski on various topics on cosmic gas, gamma-ray bursts, and/or supernovae. The group will consist of one postdoctoral researcher, two PhD students and several undergraduate students.

We are committed to promoting a diverse and inclusive community. We encourage applications from various, especially under-represented, backgrounds. We offer a family friendly, inclusive employment conditions and flexible working arrangements.

### Requirements:

- PhD degree in astronomy or a related field obtained before the beginning of the employment and not earlier than 7 years before the year of the employment. This period can be extended in case of a parental or sick leave.

### The application should contain the following:

- CV including a publication list with the personal data processing consent (see below);
- statement of research interests and plans between 1 and 3 pages;
- brief (up to one page) statement of research/programming experiences and skills;
- a copy of the PhD degree certificate (original language is acceptable), or the statement on the expected PhD thesis submission and defence;

### Selection criteria:

- research/programming experiences and skills (research experience in galaxy evolution, interstellar medium, transient astrophysics, and/or massive/exploding stars is an advantage);
- research achievements (e.g. publications, awards, etc.).

The receipt of the application will be confirmed immediately by email, so please contact Michał Michałowski if you have not received the confirmation within a few days of submission. Preference will be given to applications submitted on or before **30 May 2021**, subsequent applications will be considered until the position is filled. The selection committee may decide to hold online interviews with selected applicants.
