

## STUDENT SCHOLARSHIP

Astronomical Observatory Institute at the Adam Mickiewicz University in Poznań is seeking two students to be funded by the Polish National Science Centre through an OPUS grant. The stipend is 1000 PLN per month for 12 months. The starting date will be in spring/summer 2026. The candidates will be working with dr. hab. Michał Michałowski on various topics on cosmic gas, galaxies, gamma-ray bursts, and/or supernovae.

### Requirements:

- enrolment in the undergraduate programme (master studies having finished bachelor studies, or 4th or 5th year for a 5-year programme) at a university in Poland
- *or* enrolment in a PhD programme at a university in Poland

### Selection criteria:

- scientific achievements (including publications): 50%
- awards, distinctions, scholarships, research experience, workshops: 20%
- skills aligning with the project: 30%

### The application should contain the following:

- CV with the personal data processing consent (see below);
- transcript of university grades;

### Mandatory consent clause to be included in the CV

### **Information clause for jobseekers**
